College to conduct survey on pharmacy practice in BC

Gary Schnabel, Executive Director of the Oregon State Board of Pharmacy presented to the Board regarding a recent survey conducted in his state that focused on concerns that employer expectations on pharmacists were set too high to allow for the standards to be correctly followed. The survey conducted by the Oregon State Board led to legislation in that State that banned certain practices by employers that were believed to compromise patient safety. Changes to the Code of Ethics *Conflict of Interest Standards*

The Board has accepted a recommendation of the Ethics Committee that a change be made to the Code of Ethics *Conflict of Interest Standards* to allow registrants to dispense prescriptions to family members in an emergency situation, when another registrant is not readily available, or when in their professional judgment it is in the best interest of the patient, and it is properly documented. The Ethics committee conducted a survey earlier in the year regarding the issue of dispensing to family members and to gather thoughts from pharmacists on this topic.

Moving forward on an *Advanced Practice Pharmacist* designation

The College is moving forward with its plans to introduce an Advance Practice Pharmacist designation. Discussions will begin this Spring and Summer with interested stakeholders on the potential for such a designation. APP would provide pharmacists with additional prescribing authority and the ability to order diagnostic tests that are within their level of knowledge and experience. The College's hope is that such a designation will help improve patient safety through more effective pharmaceutical care, improve patient access to healthcare services, improve patient health outcomes, and therefore reduce cost to the health care system.

Committee memberships

The Board also approved the memberships of all the committees at its most recent meeting. Committees are reviewed and appointed annually and are a critical part of College work. They exist to not only carry out specific tasks, but in many cases function to provide advice to the College Board. The College offers its sincere thank you to all who volunteered for Committee appointments, regardless of whether they were appointed or not.
