College to propose legislative amendments that would prohibit the provision of loyalty points for prescriptions in BC

Loyalty points provided by pharmacies for prescription drugs would be prohibited under legislative amendments that the College will propose to government for consideration. If adopted, BC would be following the path of other provinces. This is similar to the Provincial PharmaCare policy that was adopted in July 2011.

50 years of registration with the College?

Board considers a role for pharmacists in distributing 'naloxone kits'

A representative from the BC Centre for Disease Control (BCCDC) Harm Reduction Strategies and Services Committee presented to the Board with a request to move naloxone from Schedule I (prescription only) to Schedule IV, effectively giving pharmacists the authority to prescribe it. An effective opioid antidote, naloxone has been proven to save lives when it is made more openly available. It is hoped by the BCCDC that take-home 'naloxone kits' containing two doses of naloxone, syringes, and other materials could be prescribed and dispensed by pharmacies to individuals at high-risk of suffering or witnessing an opioid overdose. These kits would only be dispensed to those who have undergone training from a qualified nurse and received certification to administer the drug.

While the College supports the rescheduling of naloxone as a Schedule IV drug in principle and supports the concept, much work remains to be done before this can become a reality in a community setting. It is important for the College to identify key concerns of community pharmacists, in particular, and BCCDC's implementation plan before rolling out a program. The College will be drafting a professional practice policy for review and feedback before the November Board meeting.

Board participates in strategic planning session

As part of its commitment to fulfilling its mandate, Board members and College senior staff participated in a strategic planning exercise which identified key priorities moving forward through 2012-13. Staff will develop an operations plan with performance indicators for each priority that the Board can use to track progress over the year.
