Temporary Pharmacist	Valid for up to 90 days; during an emergency situation only.	\$ 157.50
Application for Pre-registration	Valid for up to three years.	\$ 315.00
Application for Re-instatement	For re-instatement after 90 days of registration expiry; valid for up to three years.	\$ 262.50
Application for Re-instatement (late renewal fee)	For re-instatement 90 days or less after registration expiry.	\$ 131.25
Application for Certification - Injection Drug	Includes certification fee that is valid to end of current year's pharmacist registration.	\$ 105.00
